DIRECTIONS to Jones Corral – Spenceville Wildlife area:

Coming from the South (CA 99 north):

Take CA 70 North to Olivehurst approx. 18 miles

Turn right on Erle Road

Turn left on Goldfields Parkway

Turn right on Beale Road

Turn left on Griffith Avenue

Turn right on Hammonton/Smartville Road

Travel approximately 13 miles and Turn right on Chuck Yeager Road

Turn left on Waldo Road which is an un-gated gravel road

Travel down Waldo Road as it goes over the old bridge.

Take a left at the Y in the road

The road will Y again and stay to the left

Jones Corral is on the right side about a 1/2 mile

If using GPS, you can enter Spenceville Firing range to get to Waldo Road and follow directions above from there.

IMPORTANT!!!!! If you are traveling with a trailer or vehicle taller than 11.5 feet, take the route below instead. You will NOT be able to get across the old bridge using the directions above

Alternate route:

Take Interstate 80 to Hwy 65

Take Hwy 64 toward Wheatland

Once entering Wheatland, make a right onto Spenceville Road Follow the road for a few miles and make a right onto Camp Far West Rd At the Y, veer to the left. Do not take the bridge to the right Camp Far West Rd goes for several miles and ends at Speceville Rd Make a right and enter the Spenceville Wildlife Area

WATER: Please plan to supply your own water for yourself and your animals for the duration of your stay.
