ATTENTION EXHIBITORS: NO TRAINING allowed on grounds PRIOR to or DURING ratings. All entries must be paid at closing. Bitches in season allowed to run at end but must be kept away from test area until called. Check in with test secretary upon arrival. Restrooms and potable water available on site. Dogs qualifying for a rating will be awarded a rosette and are recommended to WCA for approval and issuance of a certificate. Ratings are official when confirmed by the National Office. **Blaze Orange required for all handlers.**

ELIGIBILITY OF DOGS: Read Carefully

- a) Any Weimaraner with an individual AKC number, including an AKC Limited Registration, a Purebred Alternate Listing/Indefinite Listing Privilege (PAL/ILP), or is registered with an AKC recognized foreign registry who has obtained the age of 6 months on day of test may compete for any or all ratings tests offered.
- b) Rating tests are open to all Weimaraners whose owners and co-owners are all **members of the WCA** in good standing. No dog owned by a member with an outstanding balance owed to the WCA may compete in any WCA event until the balance is paid in full.
- c) Spayed bitches/neutered males may compete for and receive ratings.
- d) Weimaraners that have disqualifying faults (as listed in the current Standard for the breed) shall be eligible to compete for or receive ratings provided they are spayed or neutered. PRIOR to being entered in a ratings test, Weimaraners with disqualifying faults must be certified by the National Office as being spayed or neutered and receive a DQF Number. All Weimaraners with AKC PAL/ILP numbers are allowed to participate without applying to the National Office. To receive a DQF Number owners must present a copy of the dog's AKC Registration Certificate or AKC recognized foreign registration certificate, and a copy of the dog's spay or neuter verification from their veterinarian to the WCA National Office, PO Box 489, Wakefield, RI 02880, Fax# 401-782-3725, wcadodge@gmail.com.
