There will be a Regular and Preferred National Champion. The results from STD and JWW from BOTH trials will be combined. Precedence will be given to the number of clean runs, followed by the most points. The dog with 4 clean runs and the most points will be the Weimaraner Club of America National Specialty Champion. If there are no teams with 4 clean runs, then the dog with the highest number of clean runs and the most points will be earn the award. In the event of a tie, there will be a run-off on the last course built. There must be at least one qualifying run. A trophy and ribbon will be awarded to the National Specialty Regular Champion and the National Specialty Preferred Champion

A ribbon will be presented to the High Scoring Dog from the Novice (A+B combined), Open, Excellent, Master STD and JWW classes. For these awards, all jump heights and both Regular and Preferred classes will be combined. The number of clean runs will be given precedence, followed by yps. In the event of a tie, there will be a run-off on the last course built. There must be at least one qualifying run.

#### OBSTACLES

Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials.

#### DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/ Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

### Online Entries

During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows: 50 runs online (33%) and 100 runs Paper (67%) *for each trial*. If either form of entry has not filled at the end of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one accordingly.

Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25 collection fee to the amount of each returned check.

#### WAIT LIST FOR WITHDRAWN ENTRIES AFTER THE CLOSING DATE/TIME

The WCA is offering a Wait List to fill openings created by withdrawn entries after the trial's closing at 6pm CT April 26, 2022. A maximum of 50 runs per trial day will be placed on the club's wait list. Any withdrawals that are received by 6pm May 9th will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial by 6pm Monday May 9th will receive a full refund.

#### COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent. A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

#### NOTICE TO EXHIBITORS

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. Weimaraner Club of America and their agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. Weimaraner Club of America reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against Weimaraner Club of America or any official thereof.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Bitches in season are not permitted to compete in Agility Trials. As such, the club will refund the entry fee for bitches unable to compete for this reason upon presentation of a veterinarian certificate. This certificate must be presented to the Trial Secretary prior to the start of judging on the first day of the trial. Injured dogs will also get refunds (minus \$9/trial entered) but a veterinarian certificate MUST be presented before the start of the trial.

**Dogs** must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. **Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Running order sheets will be posted at the trial site and available upon request, pending move-ups.

**Owners are responsible** for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.

All exhibitors must comply with the Purina Guest Rules.

### Move-Up Regulations

Dogs may be moved up to a higher class at the request of the owner. For move-ups prior to the trial, requests must be made in writing to the Trial Secretary by 6PM CT, May 9, 2022. E-mails are acceptable notification. For day-to-day move-ups, the request must be made no later than 30 minutes after end of the last class at the trial site the day preceding the move-up.

#### ADDITIONAL SITE INFORMATION

X-pens and crates may be left overnight. Neither the Events Center nor WCA will be responsible for personal articles left at the site.; no dogs may be left overnight. Please bring a mat or waterproof floor cover to place beneath your crate.

#### ENTERING A MIXTURE OF REGULAR AND PREFERRED CLASSES WITHIN THE SAME TRIAL WEEKEND MULIPLE JUMP HEIGHTS WITHIN THE SAME TRIAL DAY

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers with Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

### FIX AND GO ON (FNG)

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and <u>may not</u> compete in a jump height division <u>higher or lower</u> than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners<sup>™</sup>** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
