Courses and Birds

All stakes shall be run on a single course. Chukar and/or quail shall be released in all stakes except Open Puppy. Wild birds are also on course. Chukar and/or quail will be used for retrieving – callbacks at judges' discretion. Open All Age, Open Gun Dog and Amateur Gun Dog are retrieving stakes. Horseback handling will be permitted in all stakes.

A blank cartridge will not be fired in the Puppy stake.

Tracking collars will be permitted in all stakes as per AKC rules.

Prizes

Standard AKC rosettes to all placed dogs. Trophy to 1st place of the stake.
WCA Rotating Trophies to the first place dog in Open All Age, Field Futurity, and Amateur Gun Dog.

Futurity placements awarded according to WCA Field Futurity Rules.

OFFICIAL AMERICAN KENNEL CLUB FIELD TRIAL or HUNT TEST ENTRY FORM

Coming from the South (US-97):

From Madras go onto US-26/US-97 heading North at split of 97/197. Continue to follow US-197 North. Proceed about 35 miles (past Maupin). Turn SLIGHT RIGHT onto OR-216 (intersection with Flashing Lights). Go about 4 miles, turn left onto Conroy Rd. Follow Conroy Rd. to the 3rd driveway on the left, sign says Conley Ranch. Follow gravel road, stay to the left to camp.

Coming from the North (from Portland or Spokane):

From I-84 take the US-197 exit. Head South on US-197. Proceed about 28 miles (past Dufur). Turn Left onto OR-216 (intersection with Flashing Lights). Go about 4 miles, turn left onto Conroy Rd. Follow Conroy Rd. to the 3rd driveway on the left, sign says Conley Ranch. Follow gravel road, stay to the left to camp.

IMPORTANT: There is an all-breed field trial hosted by the German Shorthaired Pointer Club of Oregon on the same grounds September 3-5. This is typically a large trial, so there will likely be some overlap between arrival for the Western Classic and departure from the weekend trial. We will work with the landowner to reserve some parking in the lower field for Western Classic participants. Another option is to enter the GSPCO trial, get acclimated to the grounds, and get a great parking spot!

WATER: Please plan to supply your own water for yourself and your animals for the duration of your stay. The Wasco County Fairgrounds are located 10 minutes from the grounds and supply potable water and an RV waste dump if needed.

PARTICIPANTS: Are required to fill-in holes, spread horse manure, and clean up after their dogs. Dogs must be on leash, check cord, or staked out at all times unless under active judgement in the stake(s) which they are entered. Note that this trial is being held on private land and the landowners live on site.

PRIMITIVE "DRY" CAMPING: Is permitted, Porta-Potties and dumpster on site.

HORSES: No Wrangler will be available. No Stallions allowed. Please scatter your horse manure.

WEATHER: Please be prepared for all types of weather. It is Fire Season- please, no open fires and be cautious at all times.

MEALS: An Awards Banquet will be held on Thursday evening at the Riverside restaurant in Maupin. Meals will not be provided by the club during the trial.

ATTEND AT YOUR OWN RISK: The Weimaraner Club of America, their officers, directors, membership, host and landowners assume no responsibility for participants or spectators in the event of injury or damage to animals, persons or property. All participants and spectators are responsible for their own actions and are reminded that horses are inherently dangerous and unpredictable animals.

LODGING: Maupin is approx. 20 minutes from the grounds; The Dalles is about 35 minutes away. Tygh Valley and Maupin are small towns that host many tourists during the summer season. Considering that it is Labor Day Weekend prior to the Western Classic, please be sure to reserve a hotel room early.
