Directions to Test Site:

From the North: Take I-5 South to exit #216 for OR-228 toward Halsey/Brownsville Turn Left onto OR-228 E (14mi). Continue straight onto Upper Calapooia Dr (3.1mi) to a green gate; go through gate up to the Ranch House and ponds

From the South: Take I-5 North to exit #216 for OR-228 toward Halsey/Brownsville Turn Right onto OR-228 E (14mi). Continue straight onto Upper Calapooia Dr (3.1mi) to a green gate; go through gate up to the Ranch House and ponds

Only dogs that qualify on land will go on to the water retrieves, in the same order. The tests will break for lunch at a time deemed appropriate by the judges and test committee. The tests will use chukar or ducks. WCA reserves the right to change bird choices, within WCA Guidelines, based on availability. Official gunners will use 20 gauge or larger break open shotguns. Handlers when required will use .22 caliber or larger blank pistols. **All participants must wear blaze orange.** All dogs must remain on leash except while being judged. BITCHES IN SEASON may run in all levels of Retrieving Ratings but only NSD level of Shooting Ratings. BITCHES IN SEASON must remain confined until tested. There is **NO SMOKING** on Test grounds at either location. Entrants will be notified by email if start time changes due to number of entries or weather. No training aids are permitted.

ELIGIBILITY OF DOGS FOR RATING TESTS:

- A. Any Weimaraner with an individual AKC number, including an AKC Limited Registration, or an ILP number who has obtained the age of six (6) months on the first day of the tests may compete for any or all of the ratings offered.
- B. Ratings Tests are open to all Weimaraners **whose owners and co-owners are all members of the Weimaraner Club of America in good standing**. Any member with an outstanding balance owed to the WCA may not compete in any WCA event until the balance is paid in full.
- C. Spayed bitches or neutered males may compete for and receive ratings titles.
- D. Weimaraners that have disqualifying faults (as listed in the current standard for the breed) shall be eligible to compete for or receive ratings provided they are spayed or neutered. PRIOR to being entered in a ratings test, Weimaraners with disqualifying faults must be certified by the National Office as being spayed or neutered and receive a DQF Number. All Weimaraners with AKC ILP numbers are allowed to participate without applying to the National Office. To receive a DQF Number owners must present a copy of the dog's AKC Registration Certificate or AKC recognized foreign registration certificate, and a copy of the dog's spay or neuter verification from their veterinarian to the WCA National Office, 562 S State Hwy 123 Bypass #446 Seguin, TX 78155
