The event, stake and placement that qualified the dog to be entered shall be submitted with the entry. Only persons who, in the judgment of the Field Trial Committee, are qualified as amateurs, as defined in Chapter 14, Section 2, of the AKC Rules for Pointing Breed Trials may serve as scout in the National Amateur Championship Stake.
